Ballot Proposals Special Election

MAY 5, 2026

✓ Clinton County

No ballot proposals are scheduled for the May 5, 2026 Special Election.

✓ Eaton County

Ingham Intermediate School District Special Education Bond Proposal

(For some voters in Eaton County)

A bond proposal to support special education facilities and infrastructure within the Ingham Intermediate School District.

Grand Ledge Area Emergency Services Authority Bond Proposal

Authorizes the Authority to borrow up to \$22.59 million to construct and equip two new fire stations and purchase fire apparatus and related site improvements.

- Estimated 2026 millage: 3.04 mills (\$3.04 per \$1,000 of taxable value)
- Estimated average annual millage: 2.74 mills
- Bond term: up to 20 years

Ballot Proposals Special Election



✓ Ingham County

Ingham Intermediate School District Special Education Bond Proposal

Authorizes the district to borrow up to \$99.96 million to construct and improve center-based special education facilities, update instructional technology, and enhance related sites and infrastructure.

- Estimated 2026 millage: 0.55 mills (\$0.55 per \$1,000 of taxable value)
- Estimated average annual millage: 0.45 mills
- Bond term: up to 20 years

Morrice Area Schools Operating Millage Proposal

(For some voters in Ingham County)

Allows the school district to continue levying up to 18 mills on non-homestead and other non-exempt properties to maintain eligibility for the state per-pupil foundation allowance.

Stockbridge Area Emergency Services Authority Fire Protection and EMS Millage Increase

Proposes an increase of up to 2.5 mills (\$2.50 per \$1,000 of taxable value) for five years (2026–2030) to fund fire protection and emergency medical services.

- Estimated revenue in 2026: \$1.65 million

Ways to apply for an absent voter ballot application

- ✓ Online – Registered voters can request an absentee ballot online through the ***absentee voter request form***
- ✓ Call your ***clerk's office*** and ask that an application be mailed to you
- ✓ Download an application to return by mail or in person to your local ***clerk's office***
- ✓ In person at your local city or township ***clerk's office***

WAYS TO COMPLETE YOUR ABSENT VOTER BALLOT

Your completed absentee ballot should be received by your city or township clerk by 8 p.m. on Election Day. You can submit by mail, or by hand-delivering the ballot to your clerk's office or their drop box. If you are returning your ballot within two weeks of election day, we recommend hand-delivering your ballot to avoid possible postal delays.

Begin the process early by mailing in your application for an absentee ballot as soon as possible. Applications can be submitted up to 75 days before an election.

All registered voters can track their ballot by looking up their information in the ***voter information section of this website.***

EARLY VOTING IN MICHIGAN

Michigan voters have the right to cast a ballot early and in person at an early voting site before Election Day.

FIND YOUR POLLING LOCATION

Not sure where your polling location is or who your city or county clerk are? ***Michigan.gov/Vote*** can help you find that answer. Some jurisdictions provide a sample ballot so you can know who – and what – you're voting on before you head to the polls or complete your absentee ballot.

2026 LRC-PAC Endorsed Candidates



The Lansing Regional Chamber-Political Action Committee (LRC-PAC) is the political action arm of the Lansing Regional Chamber of Commerce (LRCC), representing more than 1,000 businesses across the tri-county region. The objective of LRC-PAC is to endorse candidates who support a strong, competitive, and predictable business climate and who are committed to growing our regional economy, creating jobs, and positioning Greater Lansing for long-term success.

LRC-PAC will announce additional endorsements throughout the 2026 election cycle. The endorsement process includes a review of a candidate's past performance, completion of a written questionnaire, and, in some cases, an in-person interview. Candidates may only be endorsed and considered for financial support after this process is completed and the LRC-PAC Board of Directors has formally voted. Please note that the LRC-PAC is a separate entity from the LRCC. No membership dues are used for political purposes.
